From the Leadership: ICRM Strategic Plan Update from ICRM President Melissa Dederer, CRM, IGP, FAI

I am happy to report the Board met in person in April prior to the Board and EDC meetings, during which they participated in a facilitated Strategic Planning session. The facilitator, Brian Buff, Vice President, Association Management Division at Capitol Hill Management Services (our management company) was exceptional at keeping us focused, on track, and managing some wonderful discussions about where we are, who we are, and where we are going in the future.

His agenda, and related discussions, asked us some very insightful questions, such as "what – if anything – needs to be brought forward and reviewed – anything that may have been lost or put aside during the pandemic response and recovery." The Board is always working on numerous projects so that brought about some great conversations on what we are currently pursuing and what we would like to see and accomplish in the future.

In addition, we had conversations about our challenges, goals, and objectives for the next three years as well as thinking about the "big idea" – that is, is there one major idea or theme that ties us together, as leaders of the ICRM, that we really want to accomplish.

These discussions were covered in a half-day meeting that was very well received by all Board members. Brian promised to provide us with his draft Strategic Plan within a week, and he has kept his promise. The Board is now reviewing that draft and will provide Brian with additional feedback. Brian will then produce the final version and the Board will review one last time before approving our new Strategic Plan for July 2024 through December, 2026.

This was the first time a formal Strategic Planning meeting had been held in quite a few years and the Board anticipates doing this on a regular basis going forward.
