What was the driving force behind obtaining your ICRM designation and when did you complete it?

In a time of British Columbia government downsizing, I was offered opportunity to join a newly created Central Agency, born of the Provincial Archives, with a mandate to establish a government-wide program for managing records. As the only one of five analysts to

bring an unrelated undergraduate degree and without a graduate degree in archival science, I needed to establish credibility and wanted to expand the thinking of colleagues who saw information as primarily a matter of archival preservation. I took a course in records management from another Past President, Pat Acton, and began the journey, achieving my CRM in 1989.
